Each Member Association shall be entitled a quota of entries as mentioned below.
The Host Association have to claim the quota by specifying the entries.

Eligibility	No. of Entries
All Member Associations in each category	Boys Singles – 2 Girls Singles - 2
Host Member Association additional entries in each category	Two in Boys Singles Two in Girls Singles

- Age of eligibility** :: Born on or after 1st January 2012

- Important Note** :: For grooming players from grassroot level, Badminton Association of India have taken the decision of organising U-11 Years Age Group Nationals. However, considering the Mini Age Group of the players, it has been decided that guardians will accompany their players and make their own arrangements for travel, accommodation and Fooding. Host Organisers will keep canteen facilities. However, fooding will be arranged by the Organisers on the basis of purchase of Food Coupons in advance.



- Entries Closing Date** :: **26th October 2022.**
The Entries shall be received by BAI as per the existing system with a copy to Org. Secretary. The entries are to be received through **Affiliated Units only** at **entry@badmintonindia.org** (Direct entries from the Players will not be accepted)
- Mode of Competition Regulations** :: All matches shall be played on best of three games of 21 points in rally point system.
:: The BAI Competition Regulations and General Competition Regulations shall be applicable. In the event of any dispute, the decision of the Tournament Referee will be final.
- Clothing Regulation** :: Players must comply with Regulations as per norms.
- M&Q** :: First M&Q List will be published on **2nd November 2022.**
The list of participants in order of strength will be displayed on BAI website. It shall be the responsibility of the affiliated units and the players to ensure that all the entries forwarded by the Affiliated Units appear in the M & Q (Main & Qualifying) List. If there is any omission, the player/s concerned immediately should contact their State Units and the State Units immediately inform BAI about the omission or proper rectification. After the Last date for withdrawals without penalty, no complaints shall be entertained for omission of any entry. BAI will not be responsible for any omissions of names thereafter.
- Withdrawals** :: **6th November 2022.**
If there are any withdrawals after the close of entries, it shall be intimated to BAI immediately by the Affiliated Units before the closing date of withdrawal.
Any player failing to participate in any BAI approved tournaments after draw is made, is liable to pay Rs:1500/- for each event (one thousand five hundred) fine to BAI before participating in next tournament. No exemption under any grounds (including medical) will be allowed in payment of fine. No player will be permitted to Participate in the next tournament without paying fine. Their names will not appear in the M&Q list unless the fine is paid.
Referee shall submit the withdrawal list to BAI within 24 hours after Completion of the tournament to the Chairman and Convenor TC. On receipt of the list, it will be circulated to AffiliatedUnits concerned and the fine amounts thus collected will be forwarded to the Orga nizers concerned
- Draw** :: Draw will be made on 13th November 2022 at the Managers Meeting in the Venue.

Additional shuttlecocks, if required shall be purchased by the Organizer. Sponsorship guidelines will be forwarded separately and the same shall be strictly adhered to by the organiser.
